

## MEMORANDUM OF UNDERSTANDING

Memorandum of Understanding Between Ahimsa House, The Glynn Community Crisis Center, Inc./Amity House (GCCC), and The Pet Doctor, Dr. Nicola Overman.

As partners in effort to stop domestic violence, fully recognizing that animals can be victims too, do hereby agree to support of all initiatives directly related to the quality and professional service to companion animals of victims of domestic violence. Each agency listed below is cognizant of the need for open communication so that the most extensive, non-duplicated services may be provided. Each agency will continue to be a supportive, educative vehicle for each other in the overall effort of assisting victims of domestic violence and their pets in the most comprehensive manner.

The Glynn Community Crisis Center, Inc./Amity House will house victims with their companion animals/pets as space allows. During the pets' stay at Amity House, the following care will be provided at no cost to GCCC.

Ahimsa House will provide basic veterinary care including vaccinations to reduce the spread of disease. At its sole discretion, Ahimsa House will also provide emergency veterinary necessary to treat any injury or illness due to neglect or abuse.

The Pet Doctor agrees to provide check-up/ exams, shots, and emergency services for companion animals at the following rates for animals in GCCC services.

The Pet Doctor can offer discount pricing for specific services in line with existing price breaks for other local non-profit organizations and shelter groups. These prices are subject to change due to rising costs of medication, supplies, etc. from suppliers and manufacturers which can occur without warning. In the event of rising costs, The Pet Doctor will inform the partnered groups ASAP. These price changes typically occur near the start of a calendar year, but are neither guaranteed nor predictable.

All parties to this MOU agree to maintain the confidentiality terms of the pet owner's location at Amity House and such confidentiality will also remain with the pet(s) in the care of Ahimsa House or The Pet Doctor. Ahimsa House and The Pet Doctor are, therefore, not permitted to disclose to anyone that a pet is being cared for under this agreement.

This MOU will continue the agreement between GCCC, Ahimsa House, and The Pet Doctor may be cancelled in writing at any time.
